### TRAIL USE LIABILITY RELEASE AND INDEMNITY AGREEMENT INGAWANIS MOUNTAIN BIKING COMMITTEE

I acknowledge that mountain biking, hiking, off road running, and related activities (hereinafter "activities") are hazardous activities and that injuries are a common and ordinary occurrence. I recognize that there are risks including, but not limited to, rocks, roots, waterbars, uneven and/or slippery trail conditions, other trail users, and wildlife. I freely assume these risks. I have made a voluntary choice to participate in the events and said activities. The undersigned recognizes that falls and collisions occur and injuries are common. I AGREE to ASSUME ANY AND ALL RISKS OF INJURY, DEATH, OR PROPERTY LOSS that may be associated with activities at Camp Ingawanis. I understand that helmets are required when biking at all times.

I further agree to RELEASE FROM LIABILITY and to INDEMNIFY AND HOLD HARMLESS, Boy Scouts of America, dba Winnebago Council, BSA campground Camp Ingawanis, its agents, affiliated companies, employees, their insurers, sponsors, or landowners for any injury, damage, or death to myself or to any person or property, whether caused by fault or negligence of involved parties.

I agree never to file a lawsuit against Camp Ingawanis related to said activities, even if Camp Ingawanis was negligent. However, I agree that any lawsuit filed against Camp Ingawanis shall be filed in the state of Iowa, or the Federal Court for the District of Iowa. I agree that if any part of this agreement is determined to be unenforceable, all other parts shall remain in effect and that Iowa law shall apply. This agreement is binding upon my heirs and representatives.

As a parent or legal guardian of the subject minor, I hereby agree to indemnify and hold harmless Boys Scouts of America and Camp Ingawanis from any and all claims, liabilities, demands, actions, and/or legal proceedings arising from said minors participation or usage of Camp Ingawanis facilities. I have carefully read this agreement; I understand this is a release of liability. I understand my obligations to indemnify and hold harmless even if an accident, damage, injury or death is the sole or partial fault of Camp Ingawanis. This agreement is binding upon my heirs, assigns, and legal representatives.
